Reflective account: Peristomal Mastery - Masterclass

What was the nature of the CPD activity and/or practice-related feedback and/or event or experience in your practice?

The CPD activity focused on peristomal skin care and best practices for managing ostomy-related complications. It provided a comprehensive understanding of skin anatomy, peristomal complications, patient assessment, and the effective selection of ostomy products to optimise outcomes for individuals with a stoma.

The training included:

Understanding the Skin and its Functions:

- Anatomy and physiology of the skin, including epidermis, dermis, and hypodermis.
- The acid mantle and pH balance, highlighting the impact of faecal output, sweat, and moisture on skin integrity.
- The role of digestive enzymes in peristomal skin breakdown.

Assessment and Categorisation of Peristomal Skin Complications (PSCs):

- The importance of baseline assessments and validated tools to ensure accurate diagnosis.
- The DET score for evaluating discoloration, erosion, and tissue damage.
- Classification of PSCs, including irritant contact dermatitis, allergic reactions, and infectionrelated complications.

Peristomal Management Strategies:

- Understanding the causes of leakage and its role in peristomal skin complications.
- Strategies to prevent and manage leakage, including correct pouching techniques, use of seals, and peristomal skin protection.
- The impact of mechanical trauma from repeated baseplate removal and how to minimise skin stripping.

Product Selection and Patient Empowerment:

- The importance of convexity, its role in optimising fit, preventing leakage, and managing flush/retracted stomas.
- Key considerations for choosing adhesives, supporting products (seals, tapes, skin barriers), and adhesive removers.
- Empowering patient choice in product selection to enhance confidence, security, and overall quality of life.

The session emphasised evidence-based practices supported by clinical guidelines and research, ensuring a structured, patient-centred approach to peristomal management.
